11:05 a.m.- 12:15 p.m. International Experience: What can U.S. water utilities and others learn from this experience?

According to the International Desalination Association's Yearbook from Global Water Intelligence, the capacity of desalination plants worldwide is now 15.8 billion gallons per day and has grown by 1.7 billion gpd in the past year. During this period, 700 new brackish and seawater plants were commissioned with another 244 plants under contract or in construction with a capacity of 2.4 billion gpd. Since November 2007, installed capacity of seawater plants has expanded by 29.6%. The great majority of the growth has occurred outside the United States. Why?

3:10 p.m. – 4:15 p.m. Global Climate Change Impacts & What It Does with Water Supply.

The impacts of climate change on the water cycle are complex and varied. We can anticipate a variety of potential impacts including changing temperature, precipitation patterns, the timing of precipitation, duration and distribution of snow fall, and so on. This in turn can impact water availability by changing stream/river flows, changing the timing of peak flows and reservoir refill, and even the recharge of groundwater aquifers. Water quality can be impacted as well. Potential effects include increased contaminants and higher TDS due to lower flows and higher evaporation associated with inland surface water systems, increased salt water intrusion into coastal aquifers as a result of sea level rises and other fundamental changes in water chemistry such as changes to the eH and pH of the water. Understanding and managing the impact of climate change on water quality and availability is a daunting challenge. This session is designed to help planners and managers understand the impacts of climate to water that impact its management, storage, treatment, and distribution in coastal and inland communities.
