AGENDA

- 1) Welcome/Introductions – Consent Calendar
 - The meeting was brought to order by Chair, Parry Klassen.
 - a. David Cory moved to approve, and Jeff Willett seconded, and by general acclamation the April 6, meeting action notes were approved, with one abstention.
 - b. Roll call was completed.
 - c. Daniel Cozad updated the committee on Progress Milestones and the current funding status.
- 2) CV-SALTS Contracting Update
 - Daniel Cozad summarized the current pending contract items:
 - Two RFPs have been issued; one for GIS-related tasks, and one for the initial Conceptual Model work. Submissions are due the first of June and will come back to the committee at the June meeting.
 - The RFQ for the Technical Project Manager will go out near the end of May as an open procurement activity.
- 3) CV-SALTS Salt Story Proof
 - The committee discussed the brochure format and content at length. Daniel Cozad will incorporate the committee members' comments, and forward for revision and printing for the June Workshop. Revisions to the document to include, but not limited to:
 - Remove the box containing, "Salt flows to the Delta degrading habitat for important species." Also remove any text related to this.
 - In CV-SALTS Management Goals
 - Remove the word "Enhance" from goal 5.
 - Remove the word "Urban" from goal 4.
 - Make all the boxes in this section the same size.
 - Capitalize "CV-SALTS"
 - Remove the words "and plan" from line 5 of the first paragraph in the "New Vision for the Valley" section.
 - Add an arrow or other graphic to the map to indicate tidal influence as a source of salt flowing into the Valley.
 - In the Early Implementation paragraph work in something on the Tulare Lake Basin as a closed basin, with drinking water issues.
 - In the Funding paragraph, last page, change Nutrient to Nitrate. Under Planning & Regulation, change Nutrient to Nitrate.
 - Any members with additional input on changes should email Daniel.
