AGENDA

1) Welcome and Introductions Chair

- The meeting was brought to order by Chair Parry Klassen, and roll call was completed.
- Mike Nordstrom moved to approve, and Linda Dorn seconded, and by general acclamation the November 17, 2011 meeting action notes were approved.

2) Review Expected Outcomes for January 19, 2011 Session

- Tim Moore reviewed expected outcomes for the session: To develop a project “roadmap” for 2012 supported by specified technical tasks necessary to complete the agreed upon goals. This will include expansion of the archetype strategy to include sites in different stages in the regulatory development schedule throughout the valley. This will allow for development of many tasks in parallel.

3) 2012 Roadmap for Developing the SNMP

- To demonstrate that CV-SALTS is making credible progress:
 - By end of May 2012 will have selected urgent priority archetypes and done the data analysis.
 - Goal that by end of 2012 will have gathered the data for the archetype locations.
 - Document by 2013 as basin plan amendments for those locations, and as a generic template elsewhere. Goes to the board at the end of 2013 for consideration.
 - Meeting 2014 deadline.

4) Discussion of Priority Policy Decisions/Schedule

- In response to Parry Klassen’s concern regarding the October deadline for the development of the East San Joaquin nutrient plan, Tim Moore advised that this be incorporated into CV-SALTS as a component of the expanded archetype process. The purpose of expanding the archetype identification process is to prioritize areas that are ready for change (e.g. Willows/Live Oak, EJ communities, etc.) and develop archetypes in parallel for the varying issues, and stages, in the regulatory process.
- Tim Moore reviewed a four-tiered approach for developing a basin plan amendment. The four tiers were defined as Waterbodies, Standards, Assessment and Implementation. The use of expanded archetypes will allow for addressing these tiers in parallel.
- The approach included technical tasks and policy decisions related to each of the four tiers. (See attached handout.) The technical tasks have to be turned into scope of work items, and all of the policy decisions will be the focus of the Executive Committee Policy Sessions.
- In response to a concern from Mike Nordstrom regarding the issue of potential inconsistency between IRLP and CV-SALTS, Jeanne Chilcott assured the committee that there were internal discussions in place to make sure there are no conflicts, and that what is being proposed should be complementary.
- In response to Tim Johnson’s suggestion that CV-SALTS may want to incorporate the Rice Commission’s IRLP work, Tim Moore recommended taking both the work done by the Rice

Commission, and the Wine Growers, and using them as a basis for the development of a “contractual compliance” strategy.

5) Discussion of High Priority Technical Tasks

- Daniel Cozad reviewed the current draft of the “CV-SALTS Program Work Plan.” The program includes three primary goals supported by the following seven major program elements:
 1. Policy Development, Planning, Outreach, Funding and Program Management
 2. Technical Studies/Conceptual Model
 3. Related and Integrated Efforts
 4. Implementation Planning
 5. Documentation for Approval
 6. Initial Implementation
 7. Monitoring and Reporting
- Daniel Cozad also reviewed the Conceptual Model and how it relates to tiers 1 and 2 of the basin planning approach covered in the AM session. (Presentation link http://cvsalinity.org/index.php/documents/doc_download/850-work-plan-presentation-)
- The Technical Advisory Committee will take up some elements of the Work Plan in their next meeting, mostly related to the conceptual plan.
- Daniel and Richard Meyerhof will integrate the “CV-SALTS – Strategy and Framework” into the Program Work Plan.

6) Future Items

- The June 12-14 workshop in Fresno co-sponsored by GRA and CV-SALTS was discussed.
- Pamela Creedon reminded the committee that the Harter Nitrate Report would be out in the February-March time frame should the Coalition wish to draft a response.
- Send questions and comments related to the Conceptual Plan and 5-year Work Plan to Daniel by February 3, 2012.
- Homework preparation for next meeting in email.
