A Focus on New Nitrate Regulations... a Pathway Towards Safe Drinking Water Supplies, December 12 in Modesto, CA and December 13 in Tulare, CA

The workshops will provide an opportunity for water resource leaders challenged by nitrate management to learn more about working together under the anticipated Central Valley Regional Water Quality Control Board's new nitrate regulations. The new regulations are focused on protecting and improving groundwater quality, while also ensuring safe drinking water supplies.
